Informit background

- Since 1990, 80+ databases
- **Informit Indexes** – index & abstract information.
- **Informit Plus Text** – index databases that link to full text articles.
- **Informit e-Library** – cover to cover journals, monographs and conference proceedings.

Primary Indigenous databases

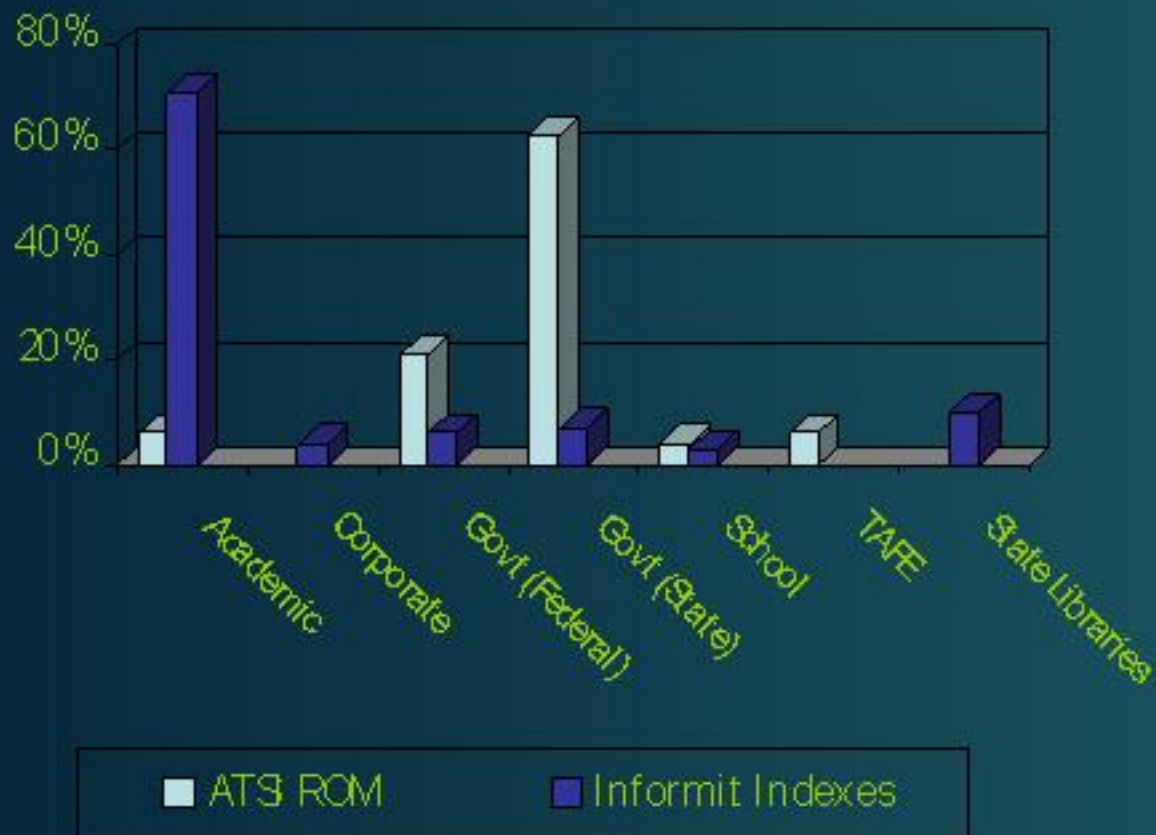
- 230,000+ records related to indigenous issues
- ATSI ROM (1998)
- Key databases:
 - Indigenous Studies bibliography (AIATSIS)
 - Indigenous Australia (ATSIC)
 - ATSIhealth (ECU)
 - Far North Queensland collection (SLQ)
- 7 index subsets
 - APAIS, AEI, AMI, AGIS, CINCH, AHB, MAIS

- Online publishing service, e-press
- Cover-to-cover access to full text journals, monographs, conference proceedings, reports
- Materials sourced from Australia, New Zealand and Asia-Pacific region
